Clinton, NC – On Monday, December 21, 2009, deputies with the Sampson County Sheriff's Office Special Investigations Division arrested Charles "Frankie" Long, age 38, of 1681 Keener Road, Clinton, NC. The arrest was the result of an undercover campaign dubbed "Operation Perk Up", which will yield additional arrests in the coming days.

Long was charged with the following: Selling Opium/Heroin; Trafficking by Delivery of Opium/Heroin; Trafficking by Possession of Opium/Heroin; and Conspiracy to Traffic Opium/Heroin. Long was placed in the Sampson County Detention Center under a \$150,000.00 bond set by Magistrate Chuck Price.

Operation Perk Up is an undercover campaign initiated by the Sheriff's Office in June of 2009 in response to anonymous drug complaints called in by citizens. Sheriff Jimmy Thornton stated, "Additional arrests will be made in the next few days, which will culminate weeks of surveillance and undercover purchases."

Sheriff Thornton encourages anyone with information on drug dealers to contact the Special Investigations Division at (910) 592-8917. "If you give us the information we'll do our best to follow-up on it. Results are not always immediate due to manpower limitations, surveillance needs, and of course the legal red tape, however we will do everything within our power to respond.", stated Thornton.

Clinton, NC – On Wednesday, December 23, 2009, deputies with the Sampson County Sheriff's Office Special Investigations Division arrested Lisa Ann Mooring, age 37, of 1681 Keener Road, Clinton, NC. The arrest was the second in an undercover operation dubbed "Operation Perk Up." Additional arrests are expected in the coming days.

Mooring was charged with "Conspiracy to Traffic Opium or Heroin" and placed in the Sampson County Detention Center under a \$100,000.00 bond set by Magistrate Alan Jackson. According to the N.C. Department of Correction website, Mooring is currently on active probation.
